

# Default Values - Element 12 Type Criminal Activity Table

Element 12 indicates the criminal activity (noted with a "Y") or potential gang involvement. If the offense is flagged with a "Y", it must include a NIBRS code G (gang older than 18), J (juvenile gang) or N(no/unknown gang activity-should default to N). If (noted with a "Z"), each of these offenses, including Animal Cruelty can indicate up to three riminal activities codes. If the "Z" is followed by letters, these offense activity options must be defaulted to these codes. The code must be able to be unchecked and additional options (up to three) available for selection by the officer. Exclude codes A, F, I and S for MCAs other than animal cruelty laws 45-8-209, 45-8-210, 45-8-211 and 45-8-217.

- LEAs can enter up to three types of activity for each offense listed below:
- A = Simple/Gross Neglect (unintentionally, intentionally, or knowingly failing to provide food,water, shelter, veterinary care, hoarding, etc.) (Only 720)
  - B = Buying/Receiving
  - C = Cultivating/Manufacturing/Publishing (i.e., production of any type)
  - D = Distributing/Selling
  - E = Exploiting Children
  - F = Organized Abuse (Dog Fighting and Cock Fighting) (Only 720)
  - I = Intentional Abuse or Torture (tormenting, mutilating, maiming, poisoning, or abandonment) (Only 720)
  - O = Operating/Promoting/Assisting
  - P = Possessing/Concealing
  - S = Animal Sexual Abuse (Bestiality) (Only 720)
  - T = Transporting/Transmitting/Importing
  - U = Using/Consuming
